


Annual HOA Meeting

PLEASE REVIEW COMMON COVENANT VIOLATIONS BELOW. Please help us by abiding by your HOA rules and protective covenants. If you'd like to report any issues please e-mail thepineshoapresident@gmail.com. Thank you!

These are the most common violations that we see in the community. Please be aware of these – very little effort is required to conform to our covenants.

- 1) Residents are required to mow their yards on a regular basis as required to maintain grass height to an acceptable level, and to maintain the landscaping and structure (fences, decks, sheds, etc.) on their property. Grass and weed growth should also be kept out of the curb / gutter area of the streets. Please make the effort to keep trash picked up around your property as well.
- 2) Trash cans are to be placed by the curb Thursday afternoon for pickup Friday. They should be returned to storage as soon as pickup is completed. This is the "24 hour" rule. Trash cans should not remain on the street longer than 24 hours for the complete cycle. <u>Trash cans MUST be stored out-of-sight from the street</u>. If you are leaving town for the weekend, please arrange for a neighbor to remove the empty trash cans from the street.
- 3) Parking: **NO overnight parking of vehicles on the street OR in cul-de-sacs.** It is an <u>Alpharetta City Code violation</u> to park in a cul-de-sac overnight. Per our HOA covenants, guest vehicles are allowed temporary street parking (8 hours or less).
- 4) Commercial and recreational vehicles and trailers: NO commercial vehicles of any kind are to be parked on any lot within any right-of-way of any `street in The Pines community. (See covenants for complete description of vehicles that are not allowed.) No disabled or unsightly vehicles are allowed / cannot be covered with a car cover. Trailers are not allowed.
- 5) Renters (tenants) are held responsible for observing the Restrictive Covenants as well as the property owner.
- 6) All forward-facing projects and repairs must be approved by the HOA Board prior to work commencing using the Project Approval Form (Project Approval Form Available in our HOA's Handbook at https://www.thepinesatkimballbridge.org/covenants/)
